1. You must be 18 years or older to sign this contract.
2. The tuxedos are due back two days after the event. After two days the tuxedo is considered late and will be charged a \$25 late fee to your credit card. **BY THE THIRD DAY IF IT IS NOT HERE ANOTHER WEEKS RENTAL** will be charged to your credit card.
3. In any event that the tuxedo is lost, stolen or damaged beyond repair, you are responsible for the cost of the tuxedo. Your credit card will be charged \$800.
4. In the event of a dispute, you will be responsible for reasonable costs for collection or cost for any disputes including attorney fees.
5. Because of the nature of our rental business, we give **NO REFUNDS**. Once an order is in shipping production it is set for delivery from our vendor warehouse to our store. If we are notified by Thursday 4:00 pm of the week prior to the wedding, that an event has been cancelled, we can only offer an in-store credit for your rental price minus \$40 cancelation fee per tuxedo. If canceled after Thursday **NO REFUND OR CREDIT** will be honored.
6. Tuxedos must be picked up by Thursday at 4:00pm. Tuxedos picked up on Friday, do not allow us enough time to make any corrections and customer agrees to receive the Tuxedo as is. After Thursday 4:00 pm a \$25 fee will be charged for any changes or replacements made to the original order.
7. We cannot be held responsible for measurements not performed in our store. We will do everything possible to make any necessary corrections; however special freight charges may apply.
